MAINTENANCE SERVICE AGREEMENT

Service: All adjustments and repairs will be made to keep the instrument in proper playing condition. All repairs must be done by B & J Music only

Coverage does not include restoration of finish and replacement of expendable accessories, mouthpiece, case, lyres, etc. The coverage is on the instrument only. Coverage does not include loss from fire, theft, loss, or damage inflicted intentionally.

Repair: Any major damage and breakage on instrument will be restored to perfect playing condition, including replacement of parts. Damage must be from normal use or accident. If major damage occurs from personal abuse or neglect, the Renter, not B & J, shall be liable for repair and/or replacement costs.

Replacement: Should the instrument be deemed beyond repair in B & J's discretion, it will be replaced with one of equal quality.
